





## TERMS & CONDITIONS FOR THE 13TH AUSTRIAN VESPA RALLY -LANGENLOIS 2025

The 13th Austrian Vespa Rally is organized by the Vespa Club Fenians Krems, ZVR 521151053 in cooperation with and under the supervision of the Vespa Club Austria (VCA), ZVR 440059738, and its volunteers from 12th to 14th of September 2025 at Langenlois, Lower Austria.

### Art. 1 Event

The "Vespa Rally" is a two-day tourism event. The region will be explored by the participants using a road book. The touristic component will be added by passage controls, time checks and uniformity trials. The route for the whole weekend is about 160 - 200 km in the region.

### Art. 2 Eligibility

Basically, eligible are all drivers of registered and insured vehicles of the brand Piaggio, types of Vespa and Cosa.

- a) Non-members in the Vespa World Club are fully eligible for participation once a year. Their entry is done by using the registration form for Non-Vespa World Club Members on www.austrianvesparally.at and payment of the full registration fee (see Art. 6). A further possibility is joining a Vespa Club affiliated to the Vespa World Club. People who are interested in the participation and have no membership in the Vespa World Club are invited to take contact with the general secretary of Vespa Club Austria: info@vespaclub.at.
- b) Eligible for full participation in the whole Vespa Rally Championship are all persons with a member-ship of a national or an international vespa club, affiliated to the Vespa World Club and who are registered using the registration tool www.vespaclub.eu/vcaers and have paid their reduced registration fee for the event (see Art. 6).
- c) Only legally licensed and insured vehicles from Piaggio are admitted to this event (see Art. 12).
- d) Due to organizational reasons there is a limit of 60 participants for the event.
- e) An accident insurance that covers events like the Vespa Rally is mandatory for all participants. Participants from Austria without national membership and all other countries of the EU must sign the form for the guest sports card of VC Austria.

For all full members of clubs affiliated to the Vespa Club Austria the insurance coverage is on the sports collective accident insurance 2024.

Participants from Italy have to care for a valid ASI license B1 on their own and have to show their license card at the registration desk.

- f) The drivers need the following equipment:
- A driving license valid in the  $\ensuremath{\mathsf{EU}}$
- A scooter that corresponds to the Austrian law (StVO).
- A stopwatch synchronization must be done manual, alarm function and operation by headset are not permitted
- Material to fix the road book / road book holder and the time card on the vehicle (for the time card is recommended a clear plastic cover).
- Wearing appropriate protective clothing is mandatory: helmet, gloves, motorcycle jacket
- Rainwear The event will take place rain or sunshine.
- Club loop







### Art. 3 Registration fee

a) For drivers, the entry fee is 125 Euros (full eligibility).

Club members of the Vespa World Club will receive discount, the entry fee for Vespa World Club members is 105 Euros.

The registration fee includes:

- official program and participation,
- information about tourism and culture in the region,
- the timekeeping
- the road book
- the timecard
- the ranking
- the memory gift
- lunch break on Saturday noon
- the lunch on Sunday
- b) For accompanying persons, the registration fee is 65 Euro and includes:
- Welcome Bag
- lunch break on Saturday noon
- the lunch on Sunday.
- c) The dinner on Saturday is not included and has to be booked additionally. [45 Euros].

Please take care for appropriate clothing for the dinner.

e) The registration gets valid after the receipt of the registration fee! (see Art. 6).

## Art. 4 Other Rules

In addition to the rules and guidelines here described, the rules of the Vespa Rally (http://www.vesparally.eu) and the Austrian law fully apply.

The participation for the participants is at their own risk and responsibility. The Vespa Club Austria, the RC Rechnitz and the volunteers are not liable for claims!

The Austrian Law (especially StVO "Österreichische Straßenverkehrsordnung") is valid for all parts of the event!

## Art. 5 Change of event program

The organizer reserves the right to change the program without prior notice.

# Art. 6 Registration and Nomination

a) The registration for non-Austrian Vespa World Club members is done via the event registration system of the Vespa World Club at: https://www.vespaworldclub.org/registrationV4/

It gets valid after confirmation by the organizer and after the deposit of the appropriate entry fee to the account of

The Membership in the Vespa World Club will be checked at the registration desk (member card of the national VC).

b) The registration for Non-Members in the Vespa World Club takes place via email to <a href="mailto:info@austrianvesparally.at">info@austrianvesparally.at</a>.

The required information is your full name, club, gender, vehicle class in which you are participating, type of participation (driver, accompanying person, Saturday evening event).







Confirmation will be made subject to availability of starting places. After the confirmation of the registration by the organizing team, the payment of the registration fee must be made to the above bank account.

- c) Payment can only be made via bank transfer. The costs for the bank transfer are with the participants.
- d) The online-registration deadline is August 15<sup>th</sup>, 2025. Registration after this date can be done, but we cannot guarantee dinner and/or lunch and/or rooms. Participation in all details cannot be guaranteed.

When the maximum number of participants is reached, the registration ends with the number of available tickets.

### e) There is no reimbursement (i.e. illness, no-show, cancelation, ...) of the registration fee!

### Art. 7 Accommodation

The participants need to take care of and pay the accommodation on their own.

Recommendations concerning accommodation, camping or camper parking are available on www.austrianvesparally.at.

### Art. 8 Classification

The classification will be done under the rules of the Vespa Rally / Vespa Rally Championship (WVC).

#### Art. 9 Event

The event office and Start/Finish are at Gartenbauschule Langenlois, Am Rosenhügel 15, 3550 Langenlois.

We will drive two (2) Giros.

Giro 1, Saturday: 10 am - 6 pm

Dinner Saturday, 8 pm, location: Gartenbauschule Langenlois

Giro 2, Sunday: 9 am - 12 am

Lunch Sunday, 2:00 pm, location: Gartenbauschule Langenlois

Presentation Ceremony Sunday, 15:00

The event will end (farewell) at Sunday 16:00!

We suggest arriving on Friday 12<sup>th</sup> of September!

The event office will be available on Friday from 16:00 - 20:00 and on Saturday from 08:00 - 09:30.

## Art. 10 Disqualification

Participants who endanger the safety of others or the reputation of this event, or are damaging vehicles or infrastructure can be excluded of further participation of the whole event without compensation by the organizing team.

Participants who violate the rules and guidelines described here, or/and submit incorrect data for their registration are automatically declined (no compensation will be paid).

## Art. 11 Protests

Protests have to be placed in written form to the Event Director latest half an hour after notice of the placements. A protest fee of 100,00 Euro will be collected. The Event Director will decide over the protests autonomously. If the protest is declined the fee will not be paid back. The protest at an official court is not possible.

The placements get valid 30 minutes after its publication.







### Art. 12 Liability

Only legally licensed and insured vehicles can be admitted to this event (have a look to Art. 2).

Each participant is driving and competing at his/her own risk!

The Vespa Club Fenians Krems, the Vespa Club Austria and the volunteers disclaim liability of drivers, pillion riders and third parties, for personal injury, damage of property and financial loss, before, during and after the event.

With nomination/registration the participant accepts the rules and guidelines for this event and exempts the Vespa Club Fenians Krems, Vespa Club Austria, the volunteers and the Vespa World Club from liability.

The participant must comply with the Austrian Law (Österreichische Straßenverkehrsordnung (STVO)) in its current version.

Examples: Driver and pillion rider of motorcycles or scooters must wear legal helmets, no driving with high beams, no honking in buildup areas.

The use of protection wear is mandatory.

## Art. 13 Acceptance of this rules

- a) The participant expressly and without exception accepts all the rules and guidelines described here.
- b) All personal data transmitted as part of the entry will be treated carefully and used only for the purpose of organizing the event.

They will not be passed on to third parties outside the Vespa World Club, except for the purposes of insurance and/or any mandatory official reporting of the respective participant to the extent necessary.

c) The Vespa Club Austria uses the personal data for the entry, organization and statistical evaluations.

The entry, organization and evaluation include in particular:

- 1) The creation of the starter list
- 2) The creation of the result lists
- 3) The creation of checklists for the checkpoints/special tests
- 4) The allocation of individual participants to teams and vehicle/classification classes
- 5) The processing of the entry and allocation of the entry fees received to the participants

The starter, result and checklists contain the start number, name, classification class and team or club of the participants. These lists are absolutely necessary for the event to take place.

The starter list and the results lists will be published - after they have been created - on the websites of the Vespa Club Austria (these are www.vespaclub.at and www.austrianvesparally.at) - analogous to similar events.

The above lists will be posted during the event to inform participants. After the event, they will be published within the Vespa World Club.

The national umbrella organizations are entitled to receive the data of their local clubs. The Vespa Club Austria will pass on the data necessary for the event to the organizer.

The personal data will under no circumstances be passed on to other people - outside the Vespa World Club and the organizer.

The organizer undertakes to protect the data from unauthorized access and to delete it again after the end of the event. The starter lists and the results lists are archived as part of the documentation of the club's history.

e) People who are not members of a club affiliated with the Vespa World Club and who have registered for this event expressly confirm that the personal data is correct and was provided voluntarily.

These people expressly accept the following sentence:

"I expressly accept that the personal data provided in the entry may be used, stored and evaluated by the Vespa World Club and the Vespa Club Austria. The Vespa Club Austria is authorized to decide on the acceptance or rejection of the entry for this







event. It may pass on the data to the organizer and the Vespa World Club and, if applicable, to the national umbrella organization. This consent includes in particular the collection, storage and use of the personal data for the purposes of evaluation after the event."

f) The Austrian Vespa Rally is an event within the framework of the Vespa World Club, so it is also particularly used for brand management and PR. A certain public and media interest is inherent in the nature of the event.

It is expressly pointed out that media representatives (on behalf of the sponsors and cooperation partners who make the event possible through their support) may be present.

The organizers also take photos and videos. These are intended for publication as part of brand management and documentation of the club's work.

It is also assumed that participants will take pictures and publish them.

By registering, paying the entry fee and participating in the event, you expressly consent to reporting and the production of photos and videos that may subsequently be published.
