12th Austrian Vespa Rally Rechnitz - Art. 13 Acceptance of these rules & data protection

- a) The participant expressly and without exception accepts all the rules and guidelines described here.
- b) All personal data transmitted in the context of the registration will be treated carefully and used only for the purpose of event organization. They will generally not be passed on to third parties outside the Vespa World Club, except for the purpose of insurance and/or any mandatory official reporting of the respective participating person to the extent absolutely necessary.
- c) The Vespa Club Austria uses the personal data for registration, organization, and statistical evaluations. The registration, organization, and evaluation include in particular:
1. The creation of the starter list
 2. The creation of the result lists
 3. The creation of checklists for the checkpoints/special tests
 4. The assignment of individual participants to teams and vehicle/classifications
 5. The handling of the registration and allocation of the received registration fees to the participants

The starter, result, and checklists contain the start number, name, classification, and team or club of the participants. These lists are absolutely necessary for the execution of the event.

The starter list and the result lists will be published on the websites of the Vespa Club Austria (www.vespaclub.at and www.austrianvesparally.at) after their creation, similar to comparable events. During the event, the mentioned lists will be posted for the information of the participants. After the event, a publication will take place within the framework of the Vespa World Club.

The national umbrella organizations are entitled to receive the data of their local clubs. The Vespa Club Austria forwards the data necessary for the execution to the organizer. The personal data will not be passed on to other persons outside the Vespa World Club and the organizer.

- d) The organizer undertakes to protect the data from unauthorized access and to delete them after the end of the event. The starter lists and result lists will be archived as part of the club's history documentation.
- e) Persons who are not members of a club affiliated with the Vespa World Club and have registered for this event expressly confirm that the personal data are correct and have been provided voluntarily.
